DMCA Policy

Introduction

Intellectual property (IP) rights are legal rights that protect original works of authorship, such as artistic works, inventions, symbols, and designs. These rights give the creator exclusive control over their intellectual property and the ability to profit from it. Usually, authors obtain IP rights from the moment they create an original work. Examples of intellectual property rights include copyrights, trademarks, patents, and trade secrets.

IP infringement occurs when someone uses, copies, or distributes intellectual property without permission from the owner. This can include using someone else's copyrighted work or trademark or creating a product that infringes on a patent. **IP infringement can result in legal actions being taken against the infringing party, including financial penalties.**

It's important to respect intellectual property rights and not engage in infringement, as it can harm the creators of the intellectual property and result in legal consequences for the infringing party.

DMCA Policy

This Digital Millennium Copyright Act ("**DMCA**") policy applies to our website ("**Site**"), which is owned and operated by 80 LV LLC ("**80LV**").

80LV respects the intellectual property rights of others and expects its users to do the same. If you believe that your copyrighted work has been infringed upon on our Site, please provide the following information to our support team at contact@80.lv. If the copyright owner is a minor (under 18), DMCA notice shall be submitted by a legal guardian.

Takedown Notice and Counter Notice

As required by the DMCA (17 U.S.C. § 512) your takedown notice should have the following information:

1. A physical or electronic signature of a person authorized to act on behalf of the owner of an exclusive right that is allegedly infringed;
2. Identification of the copyrighted work or multiple copyrighted works claimed to have been infringed;
3. Identification of the material that is claimed to be infringing or to be the subject of infringing activity and that is to be removed or access to which is to be disabled, and information reasonably sufficient to permit 80LV to locate the material;
4. Information reasonably sufficient to permit 80LV to contact the complaining party, such as an address, telephone number, and, if available, an email address at which the complaining party may be contacted;
5. A statement that the complaining party has a good faith belief that use of the material in the manner complained of is not authorized by the copyright owner, its agent, or the law; and
6. A statement that the information in the notification is accurate, and under penalty of perjury, that the complaining party is authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.

Please note that any misrepresentations of copyright infringement may be subject to liability under the DMCA and other applicable laws. Upon receipt of a valid DMCA notice, we will remove or disable access to the infringing material and take reasonable steps to notify the user who posted the infringing material ("**Infringing User**") of the takedown.

If the Infringing User believes that the material was removed or disabled as a result of a mistake or misidentification, they may send a counter-notice within 10 (ten) business days of the takedown notice. If the copyright owner is a minor (under 18), any counter-notice shall be submitted by a legal guardian.

If 80LV receives a valid counter-notice, we may send a copy of the counter-notice to the complaining party informing that the removed or disabled content may be restored after 10 (ten) business days. Unless we receive a notice from the copyright owner that they have filed an action seeking a court order against the Infringing User.

Repeat Infringers

80LV may terminate access to our Site or other services for users who are found to be repeat infringers. We may also, in our sole discretion, limit access to our Site and services and/or terminate the accounts of any users who infringe any intellectual property rights of others, whether or not there is any repeat infringement.
