### **1. Who We Are?**

1.1 This Site is a subpage of the x.la website ("XLA Site") which is a marketplace providing us with the ability to promote the Artridge project. You may see the XLA Site's Privacy Policy [here](#). All of the processing of personal data is handled by us when you use our Site, the XLA Site operator does not process your personal data when you use our Site. This Site and Platform are operated by Loonshots PR, LLC, a Delaware company with its primary offices at 251 Little Falls Drive, Wilmington, DE, 19808.

### **2. What Is This Privacy Policy About?**

2.1 This Privacy Policy explains how we collect, use, share, transfer, and "sell" (for California residents) your personal data when you use our Site or Platform (collectively "Services") or interact with us; and your data privacy rights.

2.2 Personal data is any information about you by which you can be identified or be identifiable. This can include information such as: your name, email address, mobile number; information

about your device (such as the IP address, which is a numerical code to identify your device that can provide information about the country, region or city where you are based); information relating to how you use and interact with our sites and services.

2.3 When we refer to “personal data” in this policy, we are also referencing “personal information,” as it is defined under California law.

2.4 Sometimes our sites and apps may contain links to sites and services that are not part of our offerings. These sites and services have their own privacy policies. If you follow a link to these non-Artridge sites and services, you should read the privacy policy shown on their site.

2.5 On our site, you may participate in our NFT (non-fungible token) campaign to purchase NFTs to gain early access to the Artridge device. For that we operate the Platform powered by our partner NFTify (see Section 4 “**Information We Receive From Other Sources About You**”). The data processing pertaining to the Platform is also subject to the NFTify privacy policy located [here](#).

### **3. The Types of Personal Data We Collect About You**

We will only collect your personal data in line with applicable laws. We collect your personal data in the ways provided below.

#### **3.1. When you use the Site:**

- A. directly from you, when you subscribe for our news and (or) Services and when you browse our Site (such as address, email, name, some limited data from your social media profile when you authorise via social networks);
- B. personal data we generate about you (such as IP address, your geolocation data, information on how you interact with our services, your browsing history of the content you have visited on our Site or the Platform, including how you were referred to our Site via other websites, details of your computer, mobile or other devices, for example, the unique device ID, unique vendor or advertising ID and browsers used to access our content);
- C. personal data we collect from third parties, e.g. personal data that helps us to combat fraud or which we collect, with your permission, when you interact with your social media accounts.

#### **3.2. When you use the Platform:**

- A. directly from you, when you provide us with your name, e-mail and digital wallet details to purchase our NFTs through the Platform.
- B. directly from you, when you provide us with your name, e-mail, digital wallet details and government issued ID in order to receive a refund from us.

## 2. Information We Receive From Other Sources About You

2.1 We may work with third parties, for example, business partners, sub-contractors for technical services, advertising networks, analytics providers and search information providers. If we receive information about you from them, we will always seek assurances that they are providing information to us in accordance with data protection laws and that they are transparent with you that they may share your data with us. We may use this information to update our records about you to keep them accurate.

To sell you NFT through the Platform as part of the Artridge project we employ a third-party provider NFTify.

To our best knowledge, NFTify does not collect any personal data from you as a separate controller. It may collect personal data from you on our behalf when you use the Platform in accordance with Section 3.1 of this Privacy Policy.

We have ensured that NFTify implements appropriate technical, organisational and legal measures when your data is processed.

## 3. How We Collect Personal Data?

3.1 We collect personal data when you:

- A. click the “Pre-order now” buttons on the Site;
- B. purchase an NFT from us through our Platform (see Section 4 “**Information We Receive From Other Sources About You**”)
- C. contact us to receive a refund for a purchased NFT;
- D. sign up for marketing communications;
- E. use mobile devices to access our content;
- F. access and interact with our Site through cookies and other similar technology (Please see Section 14 “**What Are Cookies? Why Do We Use Them?**” and Section 15 “**What Are Tracking Pixels? Why Do We Use Them?**”)
- G. when you contact us via email, social media, our Site or when you mention us on social media.

## 4. What Are Legal Bases And Purposes For The Processing?

4.1 **Legitimate Interests.** We process your information for our legitimate interests while applying appropriate safeguards that protect your privacy. We will not rent or sell personal information to anyone. Examples of when we rely on our legitimate interests to use your personal data include:

- A. to analyse what content has been viewed on our Site, so that we can understand how it is used and improve our content;
- B. to provide you with an ability to purchase NFTs through our Platform;
- C. to be able to refund you the price paid for the NFTs purchased through our Platform;
- D. to analyze the user’s interest in our services and to improve our services;

- E. to keep you informed about Artridge, e.g. to tell you about new features, solicit your feedback, and just keep you up to date with what's going on with Artridge;
- F. for internal administrative purposes related to our services - such as our accounting and records;
- G. to inform you of any changes to our services, such as updates to our terms and conditions;
- H. to collect and log IP addresses to improve and manage our Site;
- I. enabling you to share our content with others using social media or email;
- J. contacting you directly via social media or email if you send us emails, enter competitions or engage with us on social media or contact us;
- K. when we respond to your queries and to resolve complaints;
- L. for security and fraud prevention, and to ensure that our sites and apps are safe and secure and used in line with our Terms of use.

**4.2 Consent.** Where consent is required for our use of your personal information, by ticking the appropriate consent box or clicking the "agree", "submit", "subscribe" or otherwise communicating your consent (for example, by email), you consent to our use of that personal information for the purposes covered by the specific consent that you have given. Examples of where we ask for your consent include:

- A. to send marketing emails to you, when we have asked your permission. You can withdraw your consent to receiving these emails at any time by clicking on the "unsubscribe" link at the bottom of the email;
- B. to place non-essential cookies, or other similar technology. Where we rely on cookies to collect any personal data please see section "**What Are Cookies? - C. to verify your government-issued ID for the purpose of determining which laws should govern the refund process.

**4.3 Compliance with law.** In some cases, we may have a legal obligation to use or keep your personal data.

4.4 We may also use your personal data when carrying out automated decision-making and profiling for the purpose of identifying what information or news you might like to see from us, for example, by creating individual or group profiles.

## **5. What Are Our Security Standards?**

5.1 We endeavor to protect your data by storing it on secure servers and by using technical and organizational security measures to safeguard your personal data and to reduce the risk of loss, misuse, and unauthorized access, disclosure, and alteration. Some of the safeguards we use are firewalls and data encryption, physical access controls to our data centers, and information access controls. Please understand, however, that no system is perfect or can guarantee that

unauthorized access or theft will not occur.

5.2 Transmission of information via the Internet is not completely secure. We will do our best to protect your personal information but we cannot guarantee the security of data transmitted via the Site; any transmission is therefore at your own risk. Once we have received your personal information, we will use strict procedures and security features (as mentioned above) to try and prevent unauthorized access.

## 6. Who Will Share Your Personal Data With?

6.1 We may share your data with the following categories of selected third parties in accordance with this Privacy Policy:

- A. service providers (for example, IT services) that provide services on our behalf;
- B. analytics and search engine providers that assist us in the improvement and optimisation of our Services;
- C. law enforcement or regulatory agencies, or authorized third parties, in response to a verified request relating to a criminal investigation or alleged illegal activity or any other activity through the Site that may expose us and/or the user or any third party to legal risks or liability; and
- D. if you are going to one of our events hosted by an event partner, we may share your personal data with that partner for event administration purposes.

6.2 These third parties who may receive your data will process that data for the purposes specified above and in accordance with applicable law. We will retain a list of the third parties with whom data is shared, which will be available upon request.

## 7. How Long Do We Store Your Data?

7.1 We will not store your personal data for longer than we need to use it in accordance with this notice. Unless we let you know otherwise (or you request we erase your personal data), we will keep your personal data as you are an active participant of our NFT campaign or a purchaser of our to wish to keep in touch with us.

## 8. What Are Your Rights?

8.1 You have the following rights with regard to your personal data:

- A. **Access.** You have the right to access data we hold about you. We will need you to prove your identity before we release any personal data to you.
- B. **Rectification or erasure.** You have the right to request that we rectify or delete any personal data that we hold about you (unless we have the legal right or obligation to retain it).
- C. **Restriction.** You have the right to restrict your use of personal information if the data is inaccurate, our use of the information is unlawful or if we no longer need to use the data for the purposes for which we hold it.

- D. **Change of preferences.** You can change your data processing preferences on our Site at any time. For example, if you have given your consent to direct marketing, but have changed your mind, you can opt out of receiving marketing communications by contacting us using the details provided below or clicking the “unsubscribe” link in any communication you receive.
- E. **Automated decision making.** If you have any questions in respect of our automated decision-making processes or the accuracy of them, please send an email to [artridge@x.la](mailto:artridge@x.la) with the object: “Data Subject Request”.
- F. **Data portability.** You have the right to obtain personal data we hold about you, in a structured, electronic format, and to transmit such data to another data controller, where this is (a) personal data which you have provided to us and (b) if we are processing that data on the basis of your consent (such as your marketing preference information).
- G. **Complaints.** If for any reason you are not happy with the way that we have handled your personal data, please contact us. If you are still not happy, you have the right to make a complaint to the supervisory authority.

## 9. What Are Your California Privacy Rights?

9.1 Under the California Consumer Privacy Act, California Civil Code Section 1798.100, if you are a resident of California you may contact us with regard to the following rights in relation to your personal data:

- A. **Right of Access:** You have a right to request access to the personal data we may hold on you for the past twelve (12) months. You may submit up to two (2) requests per year of access to your personal data.
- B. **Right to Opt-In/Opt-Out of Sale of Personal Data:** For individuals sixteen (16) years or older, you have the right to opt-out of sale of personal data we may hold on you.
- C. **Right to Deletion:** You also have the right to ask us to delete personal data we may hold on you or restrict how it is used. There may be exceptions to the right to deletion for specific legal reasons which, if applicable, we will set out for you in response to your request.
- D. **Right to Non-Discrimination:** We will not discriminate against you for exercising any of your California Consumer Privacy Act rights.

We may store information on servers and equipment in other countries depending on a variety of factors, including the locations of our users and service providers. 12.1 On our Site, We use certain tools, such as cookies, to collect data about your visit to the Site such as device ID or unique identified, device type, computer and connection information, statistics on page views, traffic to and from the Site, referring URL, Internet Protocol ("IP") address and standard web log information.

12.2 A cookie is a small text file that is used to store information on your browser or your computer's hard drive when you visit a website. A cookie does not contain information that identifies a person, but it allows for the linking of your computer to the information provided by you on the Site (such as, for example, linking your IP address and other information about your experience on the Site to your preferences expressed while choosing services and purchasing products offered through the Site).

12.3 Cookies are disseminated by servers and no one may gain access to information contained therein. The information stored in cookies is gathered directly and automatically by the Site and is processed in an aggregate and anonymous manner.

**13. What Are Tracking Pixels? Why Do We Use Them?**

13.1 A tracking pixel is a small piece of code we may use to collect and share with online advertisers information on your usage of our webpages and mobile applications, such as the pages that you have visited, or the way you have interacted with them. Through the tracking pixels, your browser automatically establishes a connection with the server of an online advertiser. In this way, the online advertiser receives the information that you have accessed one of our websites or mobile apps. This allows us to ensure that we are serving ads that match your interests, when you are visiting any of the websites of the online advertiser, or a website that includes ads served by the online advertiser, and to measure the statistics of users’ interaction with our site. 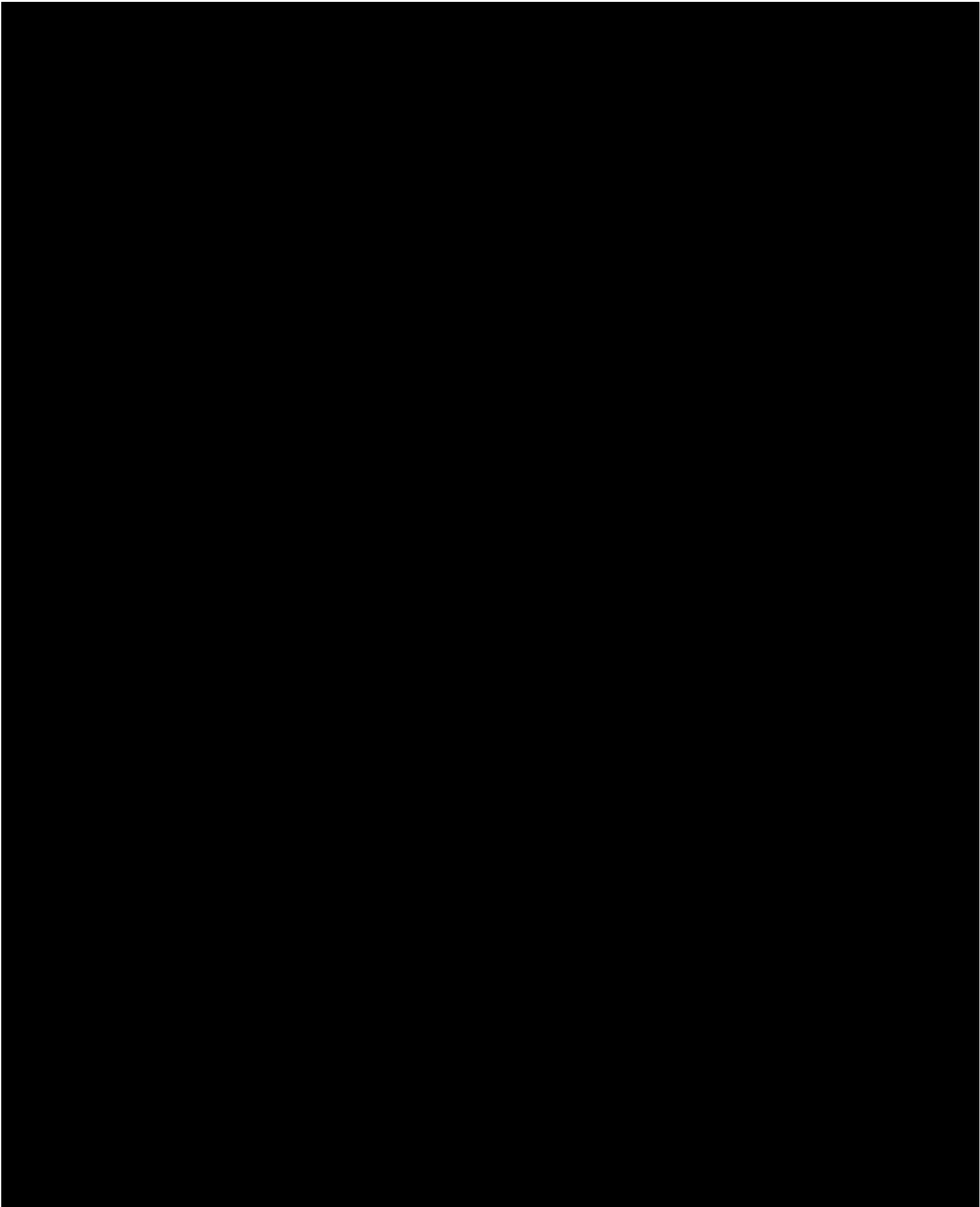

- I. through cookies and other similar technology (Please see Section 14 "**What Are Cookies? Why Do We Use Them?**" and Section 15 "**What Are Tracking Pixels? Why Do We Use Them?**")
- J. when you contact us via email, social media, our site or when you mention us on social media.

## 6. What Are Legal Basis And Purposes For The Processing?

6.1 **Legitimate Interests.** We process your information for our legitimate interests while applying appropriate safeguards that protect your privacy. We will not rent or sell personal information to anyone. Examples of when we rely on our legitimate interests to use your personal data include:

- A. to analyse what content has been viewed on our site, so that we can understand how it is used and improve our content;
- B. To analyze the user's interest in our services and to improve our services;
- C. to keep you informed about XLA, e.g. to tell you about new features, solicit your feedback, and just keep you up to date with what's going on with XLA;
- D. for internal administrative purposes related to our services - such as our accounting and records;
- E. to inform you of any changes to our services, such as updates to our terms and conditions;

- F. to collect and log IP addresses to improve and manage our site;
- G. enabling you to share our content with others using social media or email;
- H. contacting you directly via social media or email if you send us emails, enter competitions or engage with XLA on social media or contact us;
- I. when we respond to your queries and to resolve complaints;
- J. for security and fraud prevention, and to ensure that our sites and apps are safe and secure and used in line with our Terms of use.

**6.2 Consent.** Where consent is required for our use of your personal information, by ticking the appropriate consent box or clicking the “agree”, “submit”, “subscribe” or otherwise communicating your consent (for example, by email), you consent to our use of that personal information for the purposes covered by the specific consent that you have given. Examples of where we ask for your consent include:

- A. to send marketing emails to you, when we have asked your permission. You can withdraw your consent to receiving these emails at any time by clicking on the “unsubscribe” link at the bottom of the email;
- B. to place non-essential cookies, or other similar technology. Where we rely on cookies to collect any personal data please see section **“What Are Cookies? **6.3 Compliance with law.** In some cases, we may have a legal obligation to use or keep your personal data.

6.4 We may also use your personal data when carrying out automated decision-making and profiling for the purpose of identifying what information or news you might like to see from us, for example, by creating individual or group profiles.

## **7. What Are Our Security Standards?**

7.1 We endeavor to protect your data by storing it on secure servers and by using technical and organizational security measures to safeguard your personal data and to reduce the risk of loss, misuse, and unauthorized access, disclosure, and alteration. Some of the safeguards we use are firewalls and data encryption, physical access controls to our data centers, and information access controls. Please understand, however, that no system is perfect or can guarantee that unauthorized access or theft will not occur.

7.2 Transmission of information via the Internet is not completely secure. We will do our best to protect your personal information but we cannot guarantee the security of data transmitted via the Website; any transmission is therefore at your own risk. Once we have received your personal information, we will use strict procedures and security features (as mentioned above) to try and prevent unauthorized access.

## 8. Who Will Share Your Personal Data With?

8.1 We may share your data with the following categories of selected third parties in accordance with this privacy policy:

- A. service providers (for example, IT services) that provide services on our behalf;
- B. analytics and search engine providers that assist us in the improvement and optimisation of the site;
- C. law enforcement or regulatory agencies, or authorized third parties, in response to a verified request relating to a criminal investigation or alleged illegal activity or any other activity through the site that may expose us and/or the user or any third party to legal risks or liability; and
- D. if you are going to one of our events hosted by an event partner, we may share your personal data with that partner for event administration purposes.

8.2 These third parties who may receive your data will process that data for the purposes specified above and in accordance with applicable law. XLA will retain a list of the third parties with whom data is shared, which will be available upon request.

## 9. How Long Do We Store Your Data?

9.1 We will not store your personal data for longer than we need to use it in accordance with this notice. Unless we let you know otherwise (or you request we erase your personal data), we will keep your personal data as you remain a member of XLA (for example, you regularly post your thoughts on forums or have a subscription to our news) or continue to wish to keep in touch with us.

## 10. What Are Your Rights?

10.1 You have the following rights with regard to your personal data:

- A. **Access.** You have the right to access data we hold about you. We will need you to prove your identity before we release any personal data to you.
- B. **Rectification or erasure.** You have the right to request that we rectify or delete any personal data that we hold about you (unless we have the legal right or obligation to retain it).
- C. **Restriction.** You have the right to restrict your use of personal information if the data is inaccurate, our use of the information is unlawful or if we no longer need to use the data for the purposes for which we hold it.
- D. **Change of preferences.** You can change your data processing preferences at any time. For example, if you have given your consent to direct marketing, but have changed your mind, you can opt out of receiving marketing communications by contacting us using the details provided below or clicking the “unsubscribe” link in any communication you receive.
- E. **Automated decision making.** If you have any questions in respect of our automated

- F. **Data portability.** You have the right to obtain personal data we hold about you, in a structured, electronic format, and to transmit such data to another data controller, where this is (a) personal data which you have provided to us and (b) if we are processing that data on the basis of your consent (such as your marketing preference information).
- G. **Complaints.** If for any reason you are not happy with the way that we have handled your personal data, please contact us. If you are still not happy, you have the right to make a complaint to the supervisory authority.

## 11. What Are Your California Privacy Rights?

11.1 Under the California Consumer Privacy Act, California Civil Code Section 1798.100, if you are a resident of California you may contact us with regard to the following rights in relation to your personal data:

- A. **Right of Access:** You have a right to request access to the personal data we may hold on you for the past twelve (12) months. You may submit up to two (2) requests per year of access to your personal data.
- B. **Right to Opt-In/Opt-Out of Sale of Personal Data:** For individuals sixteen (16) years or older, you have the right to opt-out of sale of personal data we may hold on you.
- C. **Right to Deletion:** You also have the right to ask us to delete personal data we may hold on you or restrict how it is used. There may be exceptions to the right to deletion for specific legal reasons which, if applicable, we will set out for you in response to your request.
- D. **Right to Non-Discrimination:** We will not discriminate against you for exercising any of your California Consumer Privacy Act rights.

## 12. International Data Transfers

12.1 XLA is based in the United States and we process and store information on servers located in the United States. We may store information on servers and equipment in other countries

depending on a variety of factors, including the locations of our users and service providers. By accessing or using the site or otherwise providing information to us, you consent to the processing, transfer, and storage of information in and to the U.S. and other countries, where you may not have the same rights as you do under local law.

12.2 When we transfer the personal data of users in the EEA, UK and/or Switzerland, to our partners and subcontractors, we rely on the Standard Contractual Clauses approved by the European Commission for such transfers or other transfer mechanisms deemed 'adequate' under applicable laws.

### **14. What Are Cookies? Why Do We Use Them?**

14.1 We use certain tools, such as cookies, to collect data about your visit to the site such as device ID or unique identified, device type, computer and connection information, statistics on page views, traffic to and from the Website, referring URL, Internet Protocol ("IP") address and standard web log information.

14.2 A cookie is a small text file that is used to store information on your browser or your computer's hard drive when you visit a website. A cookie does not contain information that identifies a person, but it allows for the linking of your computer to the information provided by you on the site (such as, for example, linking your IP address and other information about your experience on the site to your preferences expressed while choosing services and purchasing products offered through the site).

14.3 Cookies are disseminated by servers and no one may gain access to information contained therein. The information stored in cookies is gathered directly and automatically by the site and is processed in an aggregate and anonymous manner.

14.4 The use of cookies and other automatic data collection tools is necessary for the proper functioning of the site and its services. However, you can block cookies by activating the setting on your browser that allows you to refuse the setting of all or some cookies. If you block all cookies (including essential cookies), XLA cannot ensure that all web pages of the site will be displayed correctly.

## 15. What Are Tracking Pixels? Why Do We Use Them?

15.1 A tracking pixel is a small piece of code we may use to collect and share with online advertisers information on your usage of our webpages and mobile applications, such as the pages that you have visited, or the way you have interacted with them.
